**APPENDIX 4C: QUARTERLY CASH FLOW REPORT AND COMMENTARY

Leading Australian cloud security technology company, FirstWave Cloud Technology Limited (ASX: FCT) (**FirstWave or Company**), provides its Appendix 4C for the 1st Quarter of FY20 ended 30 September 2019.

Cash Flow:

- Cash balance at the end of Q1 FY20 was \$2.9m, including bank guarantee deposits of \$134k
- Gross cash receipts for Q1 FY20 were \$1.1m
- Operating cash payments for Q1 FY20 were \$5.3m
- Investing cash payments for Q1 FY20 were \$1.1m, representing payments for capitalised development costs
- The net cash flow position for Q1 FY20 was an outflow of \$5.3m

Cash payments by FirstWave business segments:

- Domestic Business (Australia) - \$3.3m
- International Business - \$1.1m
- Corporate Services - \$0.9m

Estimated cash flow for Q2 FY20

Cash inflow is expected to be \$8.2m, from:

- Operating activities \$0.7m
- Investing activities \$1.3m
- Financing activities \$6.2m (capital raising proceeds, completed 26th September 2019)

Cash outflows are expected to be \$6.2m, comprising of:

- \$5.2m of operating expenditure:
 - Domestic Business (Australia) - \$3.3m
 - International Business - \$1.1m
 - Corporate Services - \$0.8m
- \$1.0m of investing expenditure
